

VITAL SOUND LABORATORY END-USER LICENSE AGREEMENT

IMPORTANT-READ CAREFULLY:

1. GENERAL

This End-User License Agreement ("EULA") is a legal agreement between you and Vital Sound Laboratory for the LanToucher Network Chat software, which may include computer software and associated media, electronic documentation and printed materials ("The Software"). By installing, copying, distributing or otherwise using The Software you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, you must not install, use or distribute The Software, and you must destroy all copies of The Software that you have.

The Software is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The Software is licensed, not sold and always remains the property of Vital Sound Laboratory.

2. LICENSING

The Software is provided free of charge, and, therefore, on an "as is" basis. You are hereby granted a non-exclusive, royalty-free license to use The Software for any purposes for an unlimited period of time as described in Section 1 and Sections 3 - 10 below.

3. RESTRICTIONS

You may not reverse engineer, decompile, or disassemble The Software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

You may not rent, lease, or lend The Software except as described in Section 7 below.

4. TRANSFER OF RIGHTS

You may permanently transfer all of your rights under this EULA, provided you retain no copies of The Software, you transfer all of The Software (including all component parts, documentation upgrades, and this EULA), and the recipient agrees to the terms of this EULA. If The Software is an upgrade, any transfer must include all prior versions of The Software.

5. TERMINATION

Without prejudice to any other rights, Vital Sound Laboratory may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of The Software.

6. COPYRIGHT

All title, including but not limited to copyrights, in and to The Software and any copies thereof are owned by Vital Sound Laboratory. All title and intellectual property rights in and to the content which may be accessed through use of The Software is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This EULA grants you no rights to use such content. All rights not expressly granted are reserved by Vital Sound Laboratory.
